**WATER RATE SCHEDULE AND MISCELLANEOUS CHARGES
FOR BILLS RENDERED ON OR AFTER MARCH 21, 2025**

GENERAL METERED SERVICE

Applicable to the use of water supplied through meters in the territory serviced by SMCMUA.

The amount of a customer's bill for a billing period will be the total of consumption and fixed service charges.

Payments made after the due date specified on the bill will incur interest charges of 1½% per month as provided by the law.

All consumptions.....	\$7.392

<u>Irrigation</u> (Applicable to all customers who request a separate water line for irrigation and/or lawn sprinkling services.)	<u>Rate IRR</u>
Flat Rate = \$10.79 per 100 cubic feet plus \$221.23 <u>Seasonal</u> Turn-off/Turn-on; drain meter.

Applicable to the entire territory serviced by SMCMUA. Charges not involving use of water.

Delivery of 24-hour shutoff notices*, turn-offs and turn-ons for any reason, are as follows**:

Standard Charge (During Normal Business Hours).....	\$73.75
Add'l Surcharge (Outside Normal Business Hours).....	\$42.35
Pump out meter pit.....	\$147.48
Annual Backflow/Detector Check.....	\$147.48
To locate and clean curb boxes for developers.....	\$73.75/hr.**
Bad Check Charge.....	\$63.21***

- * Charges waived for Senior Citizens over the age of 65.
- ** One hour minimum.
- *** Plus any penalties SMCMUA may incur from its bank for handling the bad check.

DESCRIPTION OF WATER RATES

Rate RES

Residential Customers are services to single family residences.

Rate RIC

Regular Industrial and Commercial Customers include all commercial and multiple family dwellings whose annual water usage is less than 1,200 consumption units.

Rate LIC

Large Industrial and Commercial Customers are billed monthly and have 1" meters or larger. These customers have annual usage of 1,200 consumption units (120,000 cubic feet) or more.

Rate IRR

The Irrigation rate applies to customers who have a separate water line for irrigation and/or lawn sprinkling devices.

Note: one consumption unit = 100 cubic feet = 748 gallons
